

**SAINT ADALBERT CATHOLIC ACADEMY  
2022- 2023 SCHOOL YEAR  
CATHOLIC/CONTRIBUTING PARISHIONER REGISTRATION AND TUITION INFORMATION**

**Eligibility for Catholic/Contributing Parishioner Rate Tuition:**

- ♦ Must be a registered parishioner for 1 year;
- ♦ Contribute the required amount to the Church where you are a registered parishioner (January thru December);
- ♦ Church envelopes must be used to record contributions;
- ♦ Contributions must be made weekly or monthly at Mass attendance;
- ♦ Tuition rates, for the present year or next school year, will be adjusted to non-parishioner status for church contributions not received by December 31.
- ♦ If you are a registered parishioner in a Church other than St. Adalbert, a letter must be obtained from your pastor verifying your status.

**Please choose one of the three payment plans:**

- ♦ Plan A: Full payment of tuition by July 15, 2022
- ♦ Plan B: Five payment plan due bi-monthly:  
July 15, 2022 Sep 15, 2022 Nov 15, 2022 Jan 15, 2023 March 15, 2023
- ♦ Plan C\*: Ten electronic payments via the **FACTS** program  
Ten monthly payments from July 2022 thru April 2023. Payments will be automatically deducted from your checking account. A \$43.00 fee, assessed by FACTS, will be deducted from your account after the form has been completed.

PLAN A: 1 child \$4,950.00 due by July 15, 2022  
2 children \$8,325.00 due by July 15, 2022  
3 children \$11,320.00 due by July 15, 2022

PLAN B: 1 child \$4,950.00 5 payments of \$990.00 due on or before the dates stated above.  
2 children \$8,325.00 5 payments of \$1,665.00 due on or before the dates stated above.  
3 children \$11,320.00 5 payments of \$2,264.00 due on or before the dates stated above.

PLAN C\*: 1 child \$4,950.00 10 payments of \$495.00 due monthly as stated above.  
2 children \$8,325.00 10 payments of \$832.50 due monthly as stated above.  
3 children \$11,320.00 10 payments of \$1,132.00 due monthly as stated above.

**Registration:**

The Registration Fee for returning students for the school year is \$150.00 per child.  
The Registration Fee for new students for the school year is \$175.00 per child.  
The Registration Fee is due at the time of registration and is non-refundable.  
A signed copy of the "Tuition and Fees Policy" must be returned at the time of registration.

**Additional information on the reverse side**

**\* Plan C:** Parents who choose Plan C will have a \$43.00 administrative fee, assessed by FACTS, deducted from their checking account after the completed form has been returned to school.

Parents who are already enrolled in the FACTS Program will receive a specific form that needs to be reviewed by a certain date. If there are any changes, you must notify Mrs. Morelli at the school office. If Mrs. Morelli is not notified by the specified date, you will automatically be re-enrolled in FACTS and the fee will be deducted from your checking account. If the form is correct, you may keep it for your records. This form will be sent home with your child.

**Fees:** In addition to the Registration Fee mentioned above, the following fees will be assessed throughout the year:

**Lab/Technology Fee:** \$100 per student (assessed in September)

**Family Participation/Commitment to Service:** \$100 per family (or 20 volunteer hours)

**Grade 8 Graduation Fee:** \$130 per student

**Mandatory Fundraiser:** To be announced during the school year

**Failed Payment Fee** (e.g. returned check, failed electronic payment): \$35 per occurrence

**Late Tuition Payment Fee:** \$25 per occurrence (assessed on the 30<sup>th</sup> of each month)

**FACTS Enrollment Fee\*:** \$43 (annual administrative fee assessed by FACTS for enrollees)

\*Third party fees are subject to change and our policy may be adjusted accordingly. Families will be notified of any changes.

**Financial Aid:** Partial tuition assistance for the 2022-23 school year is available through Futures in Education. Financial aid is available for eligible students in grades K to 8 who attend a Catholic Academy or Parish School within the Diocese of Brooklyn. Families must meet financial eligibility requirements to be considered. The deadline to apply is **March 31, 2022**, for families already receiving assistance and April 30, 2022, for new families.
