**2024- 2025 SCHOOL YEAR**  
**NON-CATHOLIC/NON-PARISHIONER REGISTRATION AND TUITION INFORMATION**

**Non- Catholic/Non- parishioner rates are paid by those families who:**

- ♦ Have children enrolled who are not baptized or who are not Catholic;
- ♦ Have not contributed the required amount in church support during the calendar year 2023 (i.e., January 1 - December 31, 2023);
- ♦ For one reason or another, simply decide to remain non-parishioners.

**Please choose one of the three payment plans:**

- ♦ Plan A: Full payment of tuition by July 16, 2024
- ♦ Plan B: Five payment plan due bi-monthly:  
July 16, 2024 Sep 16, 2024 Nov 18, 2024 Jan 16, 2025 March 17, 2025
- ♦ Plan C\*: Ten electronic payments via the **FACTS** program  
Ten monthly payments from July 2024 thru April 2025. Payments will be automatically deducted from your checking account. A \$45.00 fee, assessed by FACTS, will be deducted from your account after the form has been completed.

PLAN A: 1 child \$6,040.00 due by July 16, 2024  
2 children \$9,900.00 due by July 16, 2024  
3 children \$13,285.00 due by July 16, 2024

PLAN B: 1 child \$6,040.00 5 payments of \$1,208.00 due on or before the dates stated above.  
2 children \$9,900.00 5 payments of \$1,980.00 due on or before the dates stated above.  
3 children \$13,285.00 5 payments of \$2,657.00 due on or before the dates stated above.

PLAN C\*: 1 child \$6,040.00 10 payments of \$604.00 due monthly as stated above.  
2 children \$9,900.00 10 payments of \$990.00 due monthly as stated above.  
3 children \$13,285.00 10 payments of \$1,328.50 due monthly as stated above.

**Registration:**

The Registration Fee for returning students for the school year is \$150.00 per child.  
The Registration Fee for new students for the school year is \$175.00 per child.  
The Registration Fee is due at the time of registration and is non-refundable.  
A signed copy of the "**Tuition and Fees Policy**" must be returned at the time of registration.

**Additional information on the reverse side**

**\* Plan C:** Parents who choose Plan C will have a \$45.00 administrative fee, assessed by FACTS, deducted from their checking account after the completed form has been returned to school.

Parents who are already enrolled in Facts will automatically be reenrolled in the program. If you don't want to continue with Facts, please change the option on the Tuition Preference Form. If you have any questions contact Mrs. Morelli @ 718-639-7371

**Fees:** In addition to the Registration Fee mentioned above, the following fees will be assessed throughout the year:

**Lab/Technology Fee:** \$100 per student (assessed in September)

**Family Participation/Commitment to Service:** \$150 per family (or 10 volunteer hours)

**Grade 8 Graduation Fee:** \$150 per student

**Mandatory Fundraising Commitment:** To be announced during the school year

**Failed Payment Fee** (e.g. returned check, failed electronic payment): \$35 per occurrence

**Late Tuition Payment Fee:** \$25 per occurrence (assessed on the 30<sup>th</sup> of each month)

**FACTS Enrollment Fee\*:** \$45 (annual administrative fee assessed by FACTS for enrollees)

\*Third party fees are subject to change and our policy may be adjusted accordingly. Families will be notified of any changes.

**Financial Aid:** Partial tuition assistance for the 2024-25 school year is available through Futures in Education. Financial aid is available for eligible students in grades K to 8 who attend a Catholic Academy or Parish School within the Diocese of Brooklyn. Families must meet financial eligibility requirements to be considered. The deadline to apply is **March 31, 2024**, for families already receiving assistance and April 30, 2024, for new families.
